#### VII. Roads & Grounds Report I Anamaria Popescu – 2

- Two Agenda Items Accomplished The repaving of Douglass Ranch Drive and maintenance to Gordon Court and Meadowridge Lane. Maintenance is projected to have a 3–4-year life.
- Project Road Repair Drake Court Schedule for spring/summer of 2024 for seal coat.
- Concerns Regarding Quality of Work. John Pleva brought up his concern with the quality of paving that occurred on Meadow Ridge in September 2023 and produced photos documenting the road issues. Anamaria Popescu assured Mr. Pleva that Sunland will be contacted, and she will arrange to have them come out in the spring to review the concerns regarding the quality of work issues raised.
- Motion V: Aaron Reilly moves to address concerns brought up by Unit Owners on Lot 16-Pleva with the vendor for accountability of quality of work Sunland Asphalt was contracted to perform.

## VIII. Firewise Committee I Tom Washburn – Firewise Assessment and Fire Management Plan.

- 5-Year Assessment In keeping with the Firewise standards for certification a
  general assessment of the subdivision is required and must be conducted by our
  local fire department officials at Elk Creek Fire District.
- Action Items Results of the assessment provides recommendations on proactive steps the community can implement to safeguard the community in the event of a wildfire. Unfortunately, the Colorado State Forest Service (CSFS) no longer supports a second Firewise community assessment. However, CSFS indicated that it was acceptable for a Firewise community to develop an assessment of their own.
- Approval Therefore, with the combined efforts of Tom Washburn and Cathy Rheinberger, a Firewise assessment was drafted and presented to both the Elk Creek Fire District Chief, and to the Firewise committee. Approval was received from both parties. The assessment shows that Douglass Ranch is at high risk of a devastating wildfire, due to the level of forest density on the east and west side of the subdivision. - Active Design Review Committee Any planned modifications or updates to the exterior to one's property, please make sure to submit them to the Design Review Committee.
- Lot 07 The landscaping and proposed construction continue post Storm Water Pond Project. The prosed floating dock, and other structures have been closely checked with both the Committee and Nathan Campeau, Engineer of Record to the Storm Water Pond Project from Barr Engineering.
- X. Governing Documents Committee I Veris Simms, Chair Good progress has been made on DRPOA's covenants, the remaining two governing documents, Article of Incorporation and Bylaws are still under review. Target date to complete review is the end of January.
- XI. Social Committee Presentation was made before the Board of Directors whether to advocate for the Board to formalize a social committee.<sup>4</sup>
  - Advocating for: Susie Price and Kelli Jackson in support of formally establishing a social committee and the benefits.
    - Susie Price. --- Just like the Design Review, as a formal committee, the social committee can expand its scope to the following.
    - i. Organizing inclusive events such as the Fireman's dinner and holiday parties.
    - ii. Organize intra-community gatherings for the men's or women's groups.
    - iii. Organize outdoor activities such as hikes in the open space.
    - iv. Assist the Firewise committee in the annual education event.
      - 1. In Summary: Social events organized by a formal committee play a crucial role in fostering a sense of community among neighbors. These events provide a relaxed environment for neighbors to interact and build relationships, welcoming newcomers and aiding them in adjusting to mountain living. Additionally, they offer valuable information about local amenities and help newcomers feel more oriented within their new community. (i.e. schools or medical, etc.) Recognize and report suspicious activity, provided meals in a time of need (illness, injury, or emergency assistance, etc.). Social committee's aim is to foster a strong and positive communication regarding POA activities and mountain community activities. It can also minimize conflict focusing on commonalities rather than differences.

#### Kelli Jackson.

- i. As a new community member, the social committee has provided a positive outlet to meet and get to know neighbors.
- ii. **The benefit:** Fosters a rapport to engage in positive discourse and builds relationship. **Disadvantage:** Disconnection and lack of communication gives rise to disagreements as witnessed this meeting.

- iii. A formal social committee fosters a sense of community where everyone is committed to looking out for one another. It is important for us to create an environment where each individual feels valued and supported.
- iv. It's non-confrontational; no discussion of politics.
  - In Summary: Social committee has been instrumental in creating a supportive atmosphere; to feel a part of a community because of the planned social activities. Advocates for a group in whatever connects rather than bring division.
- Against: Barb Pleva
  - To date, the unofficial social committee has primarily focused on organizing gatherings and sees no connection with how it could be affiliated with DRPOA.
  - ii. Mrs. Pleva explained her concerns. Regarding the subject of a formal social group, an attorney was consulted privately and an insurance professional which advised that [should any injury or accident occur during a social event] our DRPOA insurance policy as it reads would not cover those eventualities. Instead, it would be marked against the homeowner's insurance policy.
    - 1. **In Summary:** Formalizing a social committee is not worth risking liability against a homeowner's insurance policy.
- Question Posed to the Attorney: This question of liability was then directly
  posed to Wendy Weigler for her opinion, due the perceived prejudice on the part
  of the Board.
- Attorney Wendy Weigler Response Since Mrs. Pleva had informed the assembly that she engaged an attorney regarding the issue of liability regarding the social committee, Ms. Weigler states that she legally cannot discuss the subject openly and is obligated to only discuss this issue with the Board of Directors.
